0 BIOGRAPHICAL SUMMARY

After my BSc in Economics and Rural Development from the State University of Haiti and a DES (Diplôme d'Études Supérieures) in Quantitative Applied Economics and Social Planning from the Centre de Techniques de Planification et d'Économie Appliquée (CTPEA, Haiti), I went to Belgium for an advanced MA in Development Evaluation and Management at the University of Antwerp. I'm indeed very fascinated by the economic and social development field—in which I'm pleased enough to work over several years. My first position was that of a resident Agro-economist in a France-Haiti Co-operation Project (Projet d'appui institutionnel et de formation des cadres) where my main responsibilities were to provide technical assistance in analyzing the rural producers organization (RPO), the management practices of their agricultural inputs shops, and to suggest a vocational training package in order to strengthen the RPO effectiveness in managing their common assets. As well, I've helped RPO' leaders in planning and monitoring local development projects. After completing my MA in Belgium—for which my thesis (on adjustment structural policies assessment in Haiti) has been awarded for the "Prize of the Province of Antwerp for the Belgian International Co-operation in Development in 2000", I returned to Haiti and worked as an independent consultant and teacher of applied economics, project management and evaluation. I've occupied several key positions in different private Universities in Haiti. I was also a

researcher at the Centre de Recherche en Gestion et Économie du Développement (CREGED, Université Quisqueya). Previously, I have been the Program Coordinator for a Haitian NGO—*Alliance pour la Survie et le Développement de l'Enfant* created in 1988 under the auspice of the UNICEF and became autonomous, and was recognized of public utility under the Haitian laws. There, I've developed a useful experience in HIV/AIDS prevention and communication designing, monitoring and evaluation. There, I was also involved in the negotiation process with the donors in order to fund participatory development projects dedicated to address the poverty issues in rural and marginalized areas.

In 2003, I have founded (with Jean Armand Mondélis and Joel Mérilan)—and I worked since as a consultant and team leader for—the Groupe d'études, de consultation et d'aide à la décision économique et stratégique, SA (Gecades SA). This firm is the leading independent consulting cabinet specialized in evaluation and institutional capacity building, and whose HQ is based in Port-au-Prince, Haiti. We developed several strategic alliances with several firms and Centers for research in Haiti, Québec (Canada), France and in the Caribbean in order to deliver targeted consulting services.

After contributing to the efforts made by a large range of public (Education, Economy and Finance, Culture and Communication), private and international entities (Unesco, USAID, InterAmerican Development Bank, etc.) to promote development in Haiti, I decided in 2005 to prepare a PhD in economics of development. The dissertation has been published as a book at Publibook (Paris) in conformity with the Thesis Evaluation Committee's recommendations. One of the major issues of my PhD research was the measurement of the impact of human capital on agricultural productivity, and the modeling of the productive efficiency in the Haitian agriculture with a special attention to cultural, institutional and social capital.

I'm currently a researcher and an independent consultant in these disciplines. My main research fields are micro-economics of development, project evaluation and management, managerial economics, applied micro-econometrics, efficiency measurement and analysis. My proposal for Post Doctoral Research has been accepted (now under review) by the University of Antwerp within the Thematic Group *Impact of Globalization*.
